Specifications for Vibrator Screen

- 1. The setup should consist of three screens fitted on a rigid M.S. frame, feed hopper,
- eccentric and other accessories. Three screens of different sizes should be fitted one above the other. The drives should be given from an electric motor. And the setup should provide screening efficiency.
- 2. Vibrator screen dimensions range from 360 -390 mm in width and 590- 610 mm in length.
- 3. Mesh size should be approximately 11-13 mm, 9-10 mm, and 6-7 mm.
- 4. Eccentric shaft should be coupled to mortar.
- 5. Feed Hopper should have a compatible capacity with an arrangement to control feed.

- 7. Control Panel should comprise a standard make on-off switch, Mains Indicator, and other necessary fixtures.
