Scheme of Examination /Selection Process

In connection with the recruitment notification of various Group B and C posts published vide notification Ref. No.:3313/NITK/Admin.-Estt./NTR/2023/B2 dated 17th August, 2023, the scheme of examination and selection are indicated as mentioned below:

1. In reference to clause no. 3 of the advertisement, Important Conditions of the recruitment notification mentioned above, the first stage comprised of a Computer Based Test (CBT) at the national level conducted across different cities by the NTA. Based on the performance in the CBT, candidates shall be shortlisted for a skill test. The schedule of the skill test shall be notified to the shortlisted candidates shortly.

2. (a) The candidates shall be ranked based on the marks obtained in Stage 1 test conducted by NTA. Candidates would be shortlisted for the skill test in the approximate ratio of 1:25 for post-wise and reservation-wise vacancies. There could be a few more/ less candidates based on the post/ reservation category/ administrative necessity etc.

(b) In case of many candidates scoring the same cut off marks to be eligible for the skill test, all such candidates shall be considered in their respective category.

3. The skill test will be conducted at NITK, Surathkal for the relevant trade/ specialization. The skill test is qualifying in nature only i.e. either "qualified" or "not qualified". The marks of the skill test will not be considered for preparing the final merit list. The scheme and date of skill tests will be published in the NITK, Surathkal website.

4. The final merit list would be prepared based on the marks scored in the Stage 1 exam conducted by NTA subject to qualifying in the skill test to be held at NITK, Surathkal i.e, only those candidates who have qualified in the skill test will be considered for the final merit list.

5. In case of a tie, following tie breaker shall be used:

(a) Candidate with a higher percentage in the minimum educational qualification.

(b) Candidate with a higher experience in the relevant field.

6. The minimum percentage of marks required to qualify in the skill test shall be: UR/EWS - 50%, OBC(NCL) - 45%, SC/ST/PwD/ESM - 40%.

7. Instructions to the Candidates for the Skill Test at NITK, Surathkal

(a) Candidates have to travel to the test centre, i.e, NITK, Surathkal at their own expenses and arrange their own accommodation.

(b) Candidates are to ensure that they are eligible as per the notification and NIT Non-teaching Recruitment Rules 2019.

(c) The document verification/ other verifications may be undertaken before the conduct of Skill Test. Further, if any document or information is found to be false/ misleading/ fake/ unreliable, he/she will not be permitted to attend the skill test.

Further, if any document or information is found to be false/ misleading/ fake/ unreliable, at any point after the candidate has been selected, his/her appointment will be cancelled.

(d) Applicants are advised to regularly visit the Institute website for any updates/notifications.
