Creep testing furnace

It is a custom-made modular furnace with side swivelling door on one face and a clear quartz

- 1) Should have a centrally located uniform heating zone of volume Height x Width x Length = 18cm X 14.5 cm x 20 cm.




Figure 1 Furnace drawing with all dimensions in mm

- 2) Design as per the Figure 1
- 3) Maximum temperature 1000 °C
- 4) Should have provision to purge Argon
- 5) Should have two axial openings of the same size as 20 x 20 cm for loading in the vertical direction. Lids must be provided for thermal insulation when required
- 6) It should be mountable on a stand which can be moved vertically by a height of 2 ft manually by a convenient mechanism
- 7) A clear transparent quartz window of size 8 cm x 5cm to be provided for samples inside the furnace viewing from the side as shown in figure 1
- 8) Water cooling to be provided if necessary
- 9) Surface of the furnace should not reach above 100 C.
- 10) Swivel door to be provided to seal thermally the large opening 180 mm x 120mm
- 11) The 50-x80 window is the quartz window
- 12) The heating must be from the side wall
- 13) The furnace must be lined with alumina refractories and the furnace metal frame should be thick enough to be able to withstand a load of upto 10 Kgf apart from the weight of the furnace
- 14) The empty space in the furnace must be 180 height x 100 width x 120 length
- 15) A hole will be drilled in the metal casing to introduce the indentor of diameter upto 10 mm
- 16) The temperature of the metal frame must not be more than 50 °C. Thickness of refractory 50mm with lower than 0.2 W/m/K, thermal conductivity. Preferably alumina foam. The Steel sheet used should be 2.5 mm or thicker.
