**NOTICE INVITING QUOTATIONS**

The National Institute of Technology Karnataka, Surathkal (in short - NITK, Surathkal or Institute) is an autonomous Institute of the Govt. of India [under the Ministry of HRD] imparting technical and science education. The Institute intends to **“Supplying and installation of 55nos of 2Volts,100AH,SMF Batteries at 33kv substation”** The materials as listed in the sheet enclosed. In this connection, sealed quotations are invited by the undersigned subject to the terms and conditions enumerated here under from the manufacturers/ authorized dealers/ agencies so as to reach this office on or before 05-12-2019 by 3:30 PM. The quotations shall be opened on the same day if possible.

**Terms and conditions:**

1. The intending bidder shall quote his rates in the ‘**Quotation Format**’ enclosed here with either in his letter head or using the same format. He shall sign each page with seal of the firm. Envelope super scripted as Quotation **“Supplying and installation of 55nos of 2Volts,100AH,SMF Batteries at 33kv substation”** Due on 05-12-2019” and addressed to as “The Resident Engineer, NITK, Surathkal, Post Srinivasnagar, Mangaluru – 575025” be sent so as to reach this office on or before the due date mentioned.
2. The GST registration number and the PAN number of the bidder shall be mentioned in the quotation. Quotation without this information will not be accepted.
3. Quotation may be dropped in the Tender Box kept in the office or may be sent by post/ courier. It is the responsibility of the bidder to make sure that the quotation is delivered in time. The quotations received after the due date will not be entertained.
4. The bidder should provide Min 1 year of guarantee and 2years of additional warranty from the date of expiry of guarantee for complete unit which is supplied.
5. Freight of Rate [F.O.R] – 33 KV SUBSTATION, NITK, Surathkal.
6. The rate quoted shall be valid for 90 days for its acceptance.
7. The bidder must send complete technical specification of the battery along with the quotation.
8. The material supplied should be strictly as per the specification specified and Guarantee card should be enclosed, without which the material will be rejected.
9. In case of rejection of material, one more chance shall be given for its replacement with the material conforming to the specification specified. Failure to supply the material as per the specification will result in debaring the bidder for participation in bids for a minimum of one year.
10. No advance payment will be made. The payment shall be made only after successful completion of work. No interest will be paid for delayed payments if any.

11. The rate quoted should be firm. No claim for enhancement of rate is admissible after opening of the Quotations.
12. The bidders may visit the site and see the old batteries quality and quote the rate accordingly.
13. Terms and conditions stipulated in this Notice inviting conditions are binding on the bidder.
14. The bidders should quote rates in the **quotation format** enclosed along with this document.
15. The agency must carryout servicing and maintenance jobs during the warranty period as per manufacturer recommendation.
