To consider the report of the One Man Committee submitted by Dr. H V Sudhaker Nayak on Dr. Mervin A. Herbert, Associate Professor, Department of Mechanical Engineering – Reconsideration of Resolution No.58.3.5 passed in the 58th BoG Meeting dated 14.09.2019 in the light of comments received from Hon'ble Members – Reg.

The comments received from the Hon'ble Members of the BoG in respect of the resolution of the above item were deliberated in detail. The provision of "One-time measure" is contained in the amended Statutes of NITs which speaks the following:

"The permanent faculty members who have put in more than ten years' experience, but have not acquired Ph.D. qualification as on the date of these notification shall be mapped into four-tier flexible system as one time measure as per following norms:

#### a) Permanent faculty with age fifty or above:

- i. The Assistant Professors with Academic Grade Pay of Rs.7000 shall be mapped at the level of Assistant Professor with Academic Grade Pay of Rs.8000, provided they have at least 10 credit points in their lifetime.
- ii. The Assistant Professors with Academic Grade Pay of Rs.8000 shall be mapped at the level of Associate Professor with Academic Grade Pay of Rs.9500, provided they have at least 25 credit points in their lifetime.
- iii. The Associate Professors with Academic Grade Pay of Rs.9000 shall be mapped at the level of Associate Professor with Academic Grade Pay of Rs.9500, provided they have at least 25 credit points in their lifetime.

Provided, they have been found suitable through a Selection Committee duly constituted under the Statutes."

The copy of Gazette Notification dated 24.07.2017 under Schedule E is attached as [Annexure - I (Page 1-3)].

Further, MHRD in its communication F.No.33-9 /2011-TS.III dated 06.10.2017 has communicated [Annexure -II (Page 4-6)] the recommendation of the Anomaly committee on new Recruitment Rules for Faculty in NITs and IIEST and given following guidelines for promotion of existing Assistant Professors to Associate Professors:

- The cumulative essential 'credit points are only for deciding the eligibility. The above shall be one time relaxation and will be applicable only if she / he participates in the recruitment process of same NIT where she / he has been working.
- The other contents of Notification dated 24" July, 2017 shall remain unchanged and may be read together with this communication.

As per MHRD communication F.No.33 - 9 / 2011 - TS.III dated 16.04.2019 regarding Implementation of Recruitment Rules for Faculty of NITs and IIEST, following clarification has been issued based on recommendations of the Oversight Committee on "One-time measure:

"One-time measure means completion of first round of recruitment process for respective faculty positions after amendment in-Statutes dated 24th July 2017 and subsequent approval of the process by the BoG of respective Institutes."

Copy of the same is attached as [Annexure - III (Page 7-13)].

The same has to be considered while conducting any recruitment and or promotion related matters which is also a guiding principle.

In this issue, the completion of first round of recruitment process for respective faculty positions after amendment in-Statutes was held during the year 2018. Dr. Mervin A. Herbert has been selected to the post of Associate Professor during the recruitment drive held on 09.04.2018 and approved in the 51st BoG Meeting dated 14.05.2018 under Item No.51.4.2. In view of the above, the Board resolved to reconsider the **Resolution No.58.3.5 passed in the 58th BoG Meeting dated 14.09.2019** accordingly. However, the relaxation suggested in the one-time measure doesn't apply to Dr. Mervin A Herbert, since he was eligible for next higher post without any relaxation in the eligibility requirements.

#### Resolution:

Since the BoG functions within the framework of the NITSER Act/ Statutes/ Guidelines issued from time to time by MHRD and as opined by MHRD representative in the Board, the BoG resolved that Dr. Mervin A Herbert shall be eligible for next promotion after 3 years from 14.05.2018, if otherwise he meets other eligibility conditions as per the relevant instructions.

With the above, the meeting is concluded with a vote of thanks to the Chair.
