After deliberations the Finance Committee recommended to the BOG for approval of the total budget of Rs.190.70 crores comprising of a non plan component of Rs.69.08 crores and plan grants of Rs.121.62 crores.

The Finance Committee has approved the budget estimate for 2011-12 at Rs.72.90 crores for non plan grants, and Rs.95.70 crores for plan grants.
