Subject: Representations of SC,ST,OBC, Minorities and the Women on Selection Board/Committee

Reference is invited to the Department of Higher Education's circular of even number dated 18.9.2012 on the captioned subject.

- Instructions are already in place vide DoP&T Office Memorandum OM No. 2) 39016/9(S)/89-Estt.(B) dated 16th August, 1990 and No. 39016/7(S)/2006-Estt.(B) dated 4.6.2010 for the mandatory inclusion of one member belonging to Scheduled Castes /Scheduled Tribes and one member belonging to minority community wherever a Selection Committee/Board exists or has to be constituted for making recruitment to 10 or more vacancies in Group C or Group D posts / services and where, however, the number of vacancies against which selection is to be made is less than 10, no effort should be spared in finding a Scheduled Castes / Scheduled Tribes Officers and a Minority Community Officers for inclusion in such Committees/ Boards.
- Now instructions have been slightly modified vide Department of Personnel 3) & Training Office Memorandum No. 42011/2/2014 Estt (Res) dated 13.2.14 (copy enclosed) for the mandatory inclusion of members of Scheduled Castes / Scheduled Tribes / Minority Community members and one of the, whether from general category or from the minority community or from the SC/ST/OBC community should be a lady failing which a lady member should be co opted on the Committee/Board.
- All concerned authorities are requested to kindly take note of modified 4) instructions and ensure compliance by concerned authorities under their control.

Subject: Representation of SC, ST, OBC, Minorities and the Women on Selection Board/Committees.

The undersigned is directed to draw attention of the Ministries/Departments to this Department's O.M. No.42011/15/1995-Estt(SCT) dated 11th July, 1995. Para 2 provided as follows:-

As diment

2. In partial modification of the above instructions it has now been decided that wherever a Selection Committee Board exists or has to be constituted for making recruitment to ten or more vacancies in Group 'C' or Group 'D' posts or services it shall be mandatory to have one Member belonging to SC/ST/OBC and one Member belonging to Minority Community in such Committees/Boards. Further, one of the Members of the Selection Committees/Boards whether from the general category or from the minority community or point SC/ST/OBC should be a lady failing which a lady member should be completed by the Committee/Board at may please be ensured that where the number of vacancies against which the selection is to be made is less than ten no effort should be spared in finding SC/ST/OBC officer, minority community officer and a lady officer as explained in para (2) for inclusion in such Committees/Boards."

The matter has been reviewed and in partial modification of above instructions, it has now been decided that wherever a Selection Committee/Board exist or has to be constituted for making recruitment to 10 or more vacancies in any level of posts or services, it shall be mandatory to have one Member belonging to SC/ST, one Member belonging to OBC category and one Member belonging to Minority Community in such Committees/Boards. Further, one of the members of the Selection Committee/Board, whether from the general category or from the minority community or from the SC/ST/OBC community should be a lady failing which a lady member should be co-opted on the Committee/Board. It may also be ensured that where the number of vacancies against which selection is to be made is less than ten, no effort should be spared in finding the SC/ST, OBC officer and the Minority Committee Officer and a lady officer, for inclusion in such Committees/Boards.
