NOTICE INVITING QUOTATIONS

The National Institute of Technology Karnataka, Surathkal (in short - NITK, Surathkal or Institute) is an autonomous Institute of the Govt. of India [under the Ministry of Education] imparting technical and science education. The Institute intends to "Replacement of damaged 110mm dia GI suction pipe of 40Hp pumps (Pump No.2,3 &4) at pump house". In this connection, sealed quotations are invited by the undersigned subject to the terms and conditions enumerated here under from the agencies so as to reach this office on or before 28.06.2022 by 10:00AM. The quotations shall be opened on the same day if possible.

1	Removing the rusted/damaged 110mm dia old GI pipe from the flange joint, lifting from sumps, fixing the departmentally supplied new 110mm GI pipe with CI ball type foot valve, bend and welding flanges, (shifting the new pipe, flange & foot valve to the lathe for making thread at one end of new 'C' class GI pipe for fixing coupling, foot valve, welding flange and shifting back the pipe to the work site only if required) fixing the pipe in place of the old pipe after lowering to the sump with bolt nut and washer arrangement, checking for leakage etc complete. The rate is inclusive of labour, transportation, scaffolding, welding, HOM, two coat of enamel anti-corrosive steel paint with base coat, realigning the pipe, filling the cement patches of the sump tank made while removing the old pipes. (6.0m x 3=18m)				

Terms and conditions:

- 1. The sealed quotations duly super scribed on the envelop as quotation for "Replacement of damaged 110mm dia GI suction pipe of 40Hp pumps (Pump No.2,3 &4) at pump house". Due on 28.06.2022" and addressed to as "The Superintending Engineer, NITK, Surathkal, Post Srinivasnagar, Mangaluru 575025" be sent so as to reach this office on or before the due date mentioned.
- 2. The GST registration number and the PAN number of the bidder shall be mentioned in the quotation. Quotation without this information will not be accepted. The rate quoted shall be valid for 90 days for its acceptance.
- 3. Quotation may be dropped in the Tender Box kept in the office or may be sent by post/ courier. It is the responsibility of the bidder to make sure that the guotation is delivered in time. The guotations received after the due date will not be entertained.
- 4. No advance payment will be made. The payment shall be made on after successful completion of work. No interest will be paid for delayed payments if any.
- 5. The rate guoted should be firm. No claim for enhancement of rate is admissible after opening of the Quotations.
- 6. The bidders may visit the site and see the existing pipe condition and quote the rate accordingly.
- 7. Terms and conditions stipulated in this Notice inviting conditions are binding on the bidder.
