

Advertisement for recruitment of Officers' positions (Librarian, Medical Officer, Executive Engineer and Assistant Registrar) were published vide No.5213/NITK/Estt.-Advt./2017/B1 dated January16, 2017 and No.5213/NITK/Estt.-Advt./2017/B1 dated August 11, 2017 in major national newspapers as well as in the Institute website. A total of 282 applications have been received (27 for Librarian, 21 for Medical Officer, 60 for Executive Engineer and 174 for Assistant Registrar). Shortlisting of the applications have been done by committees with Dean (Faculty Welfare) as the Chairman. After screening, 193 applicants (06 for Librarian, 17 for Medical Officer, 15 for Executive Engineer and 155 for Assistant Registrar) have been shortlisted.

Interviews were held in the Institute premises during October 25 - 26, 2017. Constitution of Selection Committees and criteria for selection of candidates have been made in accordance with the provisions of NIT Act / Statutes, Recruitment Rules and MHRD guidelines.
