NOTICE INVITING e-TENDERS [on e-Procurement mode]

- 1. National Institute of Technology Karnataka, Surathkal (in short NITK, Surathkal; hereinafter referred as the "Institute") is an autonomous Educational Institute of the Ministry of Human Recourses Development, Government of India imparting technical and science education. National Institute of Technology Karnataka, Surathkal is one of the "Institutes of National Importance" notified by the Govt. of India under the NIT Act 2007 (Act No. 29 of 2007).
- 2. The Institute hereby invites e-tenders for the below mentioned work from the eligible registered contractors of CPWD of appropriate class/ registered Furniture manufacturers/ registered furniture dealers:

The e-tenders invited are on techno-commercial basis on e-Procurement mode. The intending bidders shall submit their tenders through internet in **M/s MSTC website** <u>www.mstcecommerce.com</u> \rightarrow e-procurement \rightarrow PSU/Govt. depts \rightarrow NITK logo \rightarrow Login---. The price bid of only such bidders whose technical bid is accepted shall be opened.

- 3. The work mainly involves manufacturing and installation at site 250 numbers of single cot and 250 numbers of chairs made out of wood as specified in the Bill of Quantities in the Tender Document.
- 4. Detailed procedure for submission of e-tenders in the e-Procurement portal of M/s MSTC (a Government of India Enterprise) website is available in the Institute website. The intending bidders will have to pay a non-refundable Tender Transaction fee at the rate of 0.05% of the estimated value plus GST [subject to a minimum of ₹ 1,000 + GST and maximum of ₹ 15,000 + GST per event] to M/s MSTC Limited while submitting their e-tender.

6. **Earnest Money Deposit (EMD)**: The EMD should be submitted in favour of **NITK, Surathkal**. The EMD should be remitted through RTGS/ NEFT only.

EMD in any other form is not acceptable. Tenders received without the EMD will be rejected (except in the case of NSIC/MSME enlisted agencies). The EMD of successful bidder shall be retained (and shall be adjusted to the Security deposit). EMD shall bear no interest. EMD of the bidder is liable for forfeiture as per the terms of the tender document in case of any default.

- 7. **Performance guarantee**: The successful bidder shall deposit a performance guarantee of 5% of the quoted amount (as accepted) through RTGS/NEFT/ in the form of Bank Guarantee (in approved format) / Demand Draft / FDR of any scheduled bank drawn in favour of the **Director**, **NITK**, **Surathkal** payable at Surathkal, on intimation before executing the Contract Agreement.
- 8. **Security deposit**: The successful bidder shall deposit a further **security deposit of 2.5%** of the quoted amount through RTGS/NEFT/ in the form of Bank Guarantee (in approved format) / Demand Draft / FDR of any scheduled bank drawn in favour of the **Director, NITK, Surathkal** while executing the Contract Agreement **OR** the same shall be deducted from the contractor's work bills.
- 9. The agencies enlisted under NSIC/MSME are requested to note that the present notice inviting etenders is not for the "Supply of Goods", but for engaging a contractor under works contract for manufacturing of items as per the specific requirement of the Institute, supply and installation at site. If agencies enlisted under NSIC/MSME are interested in participating in the e-tender, they may participate subject to fulfillment of the conditions of this notice inviting e-tenders. However, they are exempted from paying EMD.
- 10. Minimum eligibility criteria for qualifying in Technical bid:

The intending bidder must satisfy all the following requirements for qualifying in the technical bid. Self-attested copy of related document should be scanned and uploaded while submitting e-tenders:

- 10.1 The bidder must be a registered contractor of Central PWD of Class I category (Furniture) or Registered Furniture manufacturers or Registered Furniture dealers. A self-attested copy of registration in case of CPWD contractors; registration under Shops and Commercial Establishment Act (or similar) evidencing registration as Furniture manufacturer/ Furniture dealer should be uploaded to e-Procurement portal while submitting e-tenders.
- 10.2 The bidder must possess GST registration self attested copy should be uploaded.
- 10.3 The bidder must possess PAN registration with Income Tax department self attested copy should be uploaded.
- 10.4 The bidder must be registered under Employees Provident Fund (EPF) Act self attested copy should be uploaded.
- 10.5 The bidder must be registered under Employees State Insurance (ESI) Act self attested copy should be uploaded.

- 10.6 The agency must have the experience of having **successfully completed** similar work as follows during the past seven financial years (Enhancement at simple 7% per annum shall be considered to bring it to the current costing level) in any Central Government department/ State Government department/Central or State Government undertakings/ Central or State government autonomous bodies/Public or Private Sector Units/ Private firms:
 - (i) At least three single similar works, each work costing not less than ₹ 19.89 lakh; OR
 - (ii) Two similar works, each work costing not less than ₹ 29.84 lakh; OR
 - (iii) One similar work of not less than ₹ 39.79 lakh.

Similar work means manufacturing, supply and installation of furniture items.

Self-attested copy of Work Experience certificate issued from Central Government department/ State Government department/Central or State Government undertakings/ Central or State government autonomous bodies/Public or Private Sector Units/ Private firms (with copy of TDS certificate in case of Private firms) should be uploaded.

- 10.7 The bidder should <u>not</u> have abandoned or suspended any awarded work of any organization during the past five financial years. Relevant proof in the form of duly sworn affidavit (as per the format in the tender document) in this respect should be signed and uploaded (and the original be furnished by the successful bidder while executing the contract agreement).
- 10.8 The bidder should <u>not</u> have been blacklisted / debarred for competing by any organization during the past five financial years. Relevant proof in the form of duly sworn affidavit (as per the format in the tender document) in this respect should be signed and uploaded (and the original be furnished by the successful bidder while executing the contract agreement).
- 11. Time is the essence of the contract and hence the work should be completed within the stipulated timeframe. Bidders, who in their opinion have the capacity to complete the work within the stipulated timeframe, shall only participate in the e-tender. Participation in the e-tender shall be deemed as the bidder has the capacity to complete the work within the stipulated timeframe.
- 12. Quoting rate for all the items is a must. The lowest tender will be determined based on the total of all the items. If rate is not quoted for any of the item(s) or quoted as zero for whatever the reason, the same shall be executed at zero cost.
- 13. A Works Contract Agreement shall be drawn with the successful bidder. Price escalation clause is not applicable to this work. Any further details required may be obtained from the office during the office hours.
- 14. The Institute reserves the right of rescheduling the calendar of events, make modifications to tender document before its submission by the bidder, cancelling the tender or accepting any tender other than the lowest or rejecting all the tenders.

1 Process of e-tender:

A) Registration:

The process involves vendor's/ bidder's registration with M/s MSTC e-procurement portal, which is free of cost. Only after registration, the vendor(s) can submit his/their bids electronically. Electronic Bidding for submission of Technical Bid as well as Commercial Bid will be done over the internet. The Vendor should possess Class III signing type digital certificate. Bids will not be recorded without Digital Signature. Vendors are to make their own arrangement for bidding from a P.C. connected with Internet. M/s MSTC is not responsible for making such arrangement.

5	Information about tenders /corrigendum uploaded shall be sent by email only during the process till finalization of tender. Hence the vendors are required to ensure that their corporate email I.D. provided is valid and updated at the time of registration of vendor with MSTC. Vendors are also requested to ensure validity of their DSC (Digital Signature Certificate).
6	E-tender cannot be accessed after the due date and time mentioned in NIT.
7	Bidding in e-tender: Vendor(s) need to submit necessary Transaction fee (to M/s MSTC) to be eligible to bid online in the e-tender. Transaction fee is non- refundable. The process involves Electronic Bidding for submission of Technical and Commercial Bid. The vendor(s) who have submitted transaction fee can only submit their Technical Bid and Commercial Bid through internet in MSTC website www.mstcecommerce.com → e-procurement →PSU/Govt depts → Login under (NITK logo) → My menu → Auction Floor Manager → live event →Selection of the live event The vendor should allow running JAVA application. This exercise has to be done immediately after opening of Bid floor. Then they have to fill up Common terms/Commercial specification and save the same. After that click on the Technical bid. If this application is not run then the vendor will not be able to save/submit his Technical bid. After filling the Technical Bid, vendor should click 'save' for recording their Technical bid. Once the same is done, the Commercial Bid link becomes active and the same has to filled up and then vendor should click on "save" to record their Commercial bid. Then once both the Technical bid &

Commercial bid has been saved, the vendor can click on the "Final submission" button to register their bid Vendors are instructed to use Attach Doc button to upload documents. Multiple documents can be uploaded. In all cases, vendor should use their own ID and Password along with Digital Signature at the time of submission of their bid. During the entire e-tender process, the vendors will remain completely anonymous to one another and also to everybody else. The e-tender floor shall remain open from the pre-announced date & time and for as much duration as mentioned above. All electronic bids submitted during the e-tender process shall be legally binding on the vendor. Any bid will be considered as the valid bid offered by that vendor and acceptance of the same by the Buyer (i. e NITK) will form a binding contract between Buyer and the Vendor for execution of supply. It is mandatory that all the bids are submitted with digital signature certificate otherwise the same will not be accepted by the system. Buyer reserves the right to cancel or reject or accept or withdraw or extend the tender in full or part as the case may be without assigning any reason thereof.
