- 2. Tender documents can be obtained from NITKS Hostels office on specific request. Tender document will be issued from 1<sup>st</sup> May 2019 to 16<sup>th</sup> May 2019 up to 2.30 pm. The tender notice is also published in NITK website <a href="www.nitk.ac.in">www.nitk.ac.in</a>. Interested firms/ individuals can down load the tender document and submit the Price Offer in the form of Demand Draft drawn in favour of Professor in charge, Hostel Affairs, NITKS Hostels payable at Surathkal.
- 3. Interested parties should drop their bids completed in all respects in the drop box latest by 26/05/2019 before 3.30 pm in the Hostel office along with Earnest Money Deposit of minimum Rs. 10,000/- (Rs. Ten Thousand only) in the form of Demand Draft drawn in favour of **Professor in charge, Hostel Affairs, NITKS Hostels** payable at Surathkal. The 'Special conditions', 'Instructions to tenderers' and 'Condition of Sale', forming part of the enquiry (Annexure B, Annexure C, Annexure D respectively) along with Section II to V are to be signed and submitted along with the offer. The tender for the Bids will be opened at 4: 00 PM (16.00 hrs) on 29<sup>th</sup> May 2019 in the presence of the bidders who are present.
- 4. EMD shall bear no interest. Any bid not accompanying with EMD is liable to be treated as non-responsive and rejected.
- 5. EARNEST MONEY DEPOSIT (EMD) will be refunded without any interest to successful tenderer only after satisfactory execution of the contract and fulfilment of all contractual obligations or it may be adjusted while remitting the value of the sale before taking delivery of the item.
- 6. The tender documents sent through courier or post, should reach the above address sufficiently in advance of the closing date and time of tender.
- 7. The bidder should have an experience of Purchase of such scrap Material of minimum One Lakh Rupees from any of the State/Central Governments/Public Sector Units(PSU's) etc in any one of the last four financial years. The documentary proof of such sale should be produced along-with the Bid Offer.
- 8. The bidder should possess Income tax PAN number.
- 9. The bidder should possess GST registration and TIN number.

- 10. The highest bidder/ offer do not get any right to demand acceptance of his offer. NITKS Hostels reserves the right to accept /reject/cancel any bid, withdraw any portion of the Auction/ tender/ property/material/goods at any stage from Auction/tender. Even after acceptance of bid/ issue of delivery order or release order/deposit of full value by successful bidder, NITKS Hostels can reject/cancel the deal without assigning any reason thereof. In the event of such rejection/ cancellation/withdrawal, NITKS Hostels, shall refund the value of Auction/ tender Property, if paid for, to the successful bidder. NITKS Hostels shall not be responsible for any damages/ loss whatsoever to the successful bidder on account of such withdrawal.
- 11. Clarification of Tender Document: A prospective bidder requiring any clarification of the Tender document may communicate to the "contact person" given in this notice inviting tender. The contact person will respond to any request for clarification for the tender Document received not later than 4 working days prior to the last date for the receipt of bids.
- 12. Amendment of Tender document: At any time prior to the last date of receipt of bids, NITKS Hostels office may for any reason, whether at its own initiative or in response to a clarification requested by prospective bidder, modify the Tender document by an amendment.
- 13. NITKS Hostels may at its own discretion extend the last date for the receipt of bids.
- 14. The bid shall be written in English language and any information printed in other language shall be accompanied by an English translation, in which case for the purpose of interpretation of the bid, the English translation shall govern.
- 15. The tender documents submitted in any other form like Telex/Fax/Tele Fax/Telephones/E-mail will not be considered.
- 16. No tender documents submitted or received by post after the specified date and time shall be accepted or be eligible for consideration.
- 17. In event of office remaining closed on the date of opening of the tender for any unforeseen reason, the tender shall be received and opened on the next working date.
- 18. Tenderers should sign on all the pages of the tender document.

#### **General rules**

- 1. Conditional and / or combined offer(s) in tender shall be liable for rejection. Acceptance or rejection or deviation of tender terms and conditions shall be finally decided by the Professor in charge, NITKS Hostels.
- 2. The Professor in charge, NITKS Hostels reserves the right to accept or reject highest tender without assigning any reason and may sell the material to one or more than one tenderer as it may deem fit and no claim/ complaint in this regard from the highest bidder will be entertained.
- 3. In the event of any dispute with regard to Sales Tax or any other statutory levies the matter has to be taken up directly with the concerned Authorities by the purchaser.
- 4. Should the purchaser happen to be relative of any employee of the Department or any member of Auction Committee, he shall inform the Authority of the said fact while submitting his tender failing which his contract may rescinded, if and when the fact consequently comes to light and he shall be liable to make good any loss or damages resulting from such rescission.
- 5. Intending tenderers may seek for any clarification before tendering, submission of offer implies the tenderer has obtained all clarification required.
- 6. The Tenderer must sign each and every page of the General Terms & Condition, Special Terms & conditions and schedules to the tender which from an integral part of the tender.
- 7. Unless otherwise specified, the rates will be considered as basic rate without taxes & duties which will be extra as would be applicable on the date of delivery.
- 8. In all cases the rates should be quoted both in words and figures. Any alteration and / or overwriting should be duly authenticated by the tenderer's signature.
- 9. The Professor in charge, NITKS Hostels shall have the right to withdraw/cancel/issue amend to the Tender document to clarify amend, modify supplement or delete any of the condition clause stated in the tender, for which tenderer shall not be entitled to claim any cost, expenses in connection with submission of offer. In case the tender is withdrawn/cancelled, the EMD will be refunded without interest.
- 10. Payment Terms: Full payment of the stockpiles has to be made within ten days from the date of receipt of the Sale Order or earlier as will be specified in the Sale Order.
- 11. Lifting Period: Entire Quantity has to be lifted within 7 days strictly after receiving sale order. Advice: Any delay in taking delivery of materials beyond the specified period may attract ground rent as per general terms or may lead to termination of contract.
- 12. Inspection: The interested tenderers may inspect the goods to be tendered on working days from 6<sup>th</sup> May 2019 to 16<sup>th</sup> April 2019 between 11.00 am to 5.00 pm except Saturday / Sunday or holidays at NITKS Hostels Office with prior permission. The person inspecting the items should record their firm's name, his name, and his position in the Inspection Register. The person should produce proof of documentary evidence like authorization letter in their letter pad/visiting card/identification card, driving license, passport, PAN card etc. before inspection. The Tenderers will be permitted to inspect the items only once and they will not be entertained again.

- 13. During evaluation of the bids, the Professor in Charge, NITKS Hostels may, at his discretion, ask the bidder for clarification of his bid.
- 14. No bidder shall contact the office of Professor in Charge, NITKS Hostels on any matter relating to his bid from the time of the bid opening to the time the issue of work order. All bidders are strongly advised to furnish all material information in the bid itself.
- 15. Incomplete and conditional offers are liable for rejection.

#### SPECIAL CONDITIONS:-

- 1. The sale shall be on 'as is where is' basis.
- 2. All labour, tools and equipment for loading the items from NITKS Hostel campus Site to buyer's trucks shall be at the cost of the buyer.
- 3. The personnel employed for the disposal action (job) shall strictly obey the Safety Rules in force.
- 4. The material shall be collected in trucks licensed to carry such products. The quantity shall be assessed on the basis of weightment of trucks.
- 5. The quantity of the scrap indicated in the list is approximate and sale will be affected on the basis of weightment on Weigh Bridge at the time of taking delivery.
- 6. The buyers shall have to make full payment for the approximate quantity at the contract rate plus taxes in advance. Any additional payment if required on weightment of the material, the same shall be made to NITKS Hostels before taking delivery of the material.
- 7. The bidders are required to indicate their PAN Number in their offer since it has been mandatory by Income Tax Department.

#### ANNEXURE -C

#### CONDITIONS OF CONTRACT

- 1. In case of taking weight of the items at the time of delivery, the weight will be ascertained in the Weigh Bridge to be arranged by the bidder before a committee. The successful bidder shall remit the cost of the Scrap and applicable taxes as prescribed in the Sale Order before taking delivery of the items from NITKS Hostel premises.
- 2. If the successful bidder fails to pay the required Security Deposit (SD) and the purchase price and take delivery of the items as prescribed in the Sale Order, the contract for the purchase of the material listed in the tender notice shall stand cancelled and the EMD/SD/purchase price, if any, paid shall be forfeited without prejudice to the rights of NITKS Hostels to recover damages on account of such breach. The materials/scrap will thereafter be sold at the risk and cost of the defaulted tenderer and the expenditure incurred or losses sustained thereon shall be made good by the tenderer. The tenderer shall not have any right or claim in respect of the materials thereafter and the EMD/SD shall stand forfeited without prejudice to NITKS Hostel right to recover any loss or damage that may be suffered by NITKS Hostel. NITKS Hostel reserves the right to take such further action as deemed fit against defaulting bidder as may be authorized by law in force.
- 3. Sale will be based on actual quantity available. No claim for variation in quantities will be entertained. Photographs of the lots will be taken and kept for record.
- 4. The tenderer will not be permitted to sort out the materials. However, if any of the item which NITKS Hostel feels to be useful in future for their use will be withdrawn from the sale lot.
- 5. The job shall be done without damaging the premises/roads/drains/etc. The buyer shall make good the damages, loss, etc., in the event of any occurrence otherwise.
- 6. All statutory payments, like minimum wages prescribed, compensation in case of accident or loss, etc., to the workers employed by the tenderer for the removal of the items shall be borne by the tenderer. Safety Rules applicable to Contractor's Workmen should be strictly followed while working in NITKS Hostel premises.
- 7. The sale is subject to all the terms and conditions prescribed in the tender document and resultant sale order
- 8. Any clarification required may be obtained before submission of the tender.
- 9. ACCEPTANCE OF OFFER: The successful tenderer will be intimated about the acceptance of their offer under Registered Post/telephonically if not present during opening of bids.

- 10. Item wise (Unit & Total) price be quoted. For award of contract, the price of each item will be considered. If any contractor has offered the highest price of all the items then the total contract will be awarded to the contractor. If any contractor has offered the highest price for one item then the contract for that item will be awarded to that contractor. The successful bidder (s) will be required to deposit the total bid/quoted amount by means of Demand Draft in favour of **Professor in Charge**, Hostel Affairs, NITKS Hostels, within 03 working days from the date of award of contract and the items will be lifted within 07 days of the receipt of confirmed sale order by the firm/individual. Failure to do so shall result in forfeiting of EMD. The EMD of the successful bidder and the unsuccessful bidders will only be released after submission of quoted amount in the prescribed form by the successful bidder. If the successful bidder fails to deposit the quoted amount within stipulated date, the EMD of the first highest quoted (H1) firm will be forfeited and the second highest firm will be considered, if the second highest quoted firm (H2) is willing the pay at par the amount quoted by H1 bidder and the contract will be awarded to H2 bidder. If the H2 firm is unwilling to accept the same, then the whole tendering process will be treated as cancelled and no representation in this regard will be entertained. Failure in this regard shall be counted as bad performance and may be viewed adversely in award of future contracts or grant on continuing the association to such parties. This will be in addition to immediate remedial measures actions available to NITKS Hostels under the relevant laws
- 11. The tenderer should return the duplicate copy of the contract duly signed and stamped as token of acceptance. Security Deposit 10% of final purchase value should be deposited after finalization of rates.
- 12. DEFAULT IN PAYMENT: In case of default in payment within the time limits specified in the terms and conditions of the tender, the contract automatically stands cancelled thereby forfeiting the Earnest Money Deposit.
- 13. The office of Professor in Charge, NITKS Hostels reserves the right to accept or not to accept payment beyond the specified time limit.
- 14. DEFAULT IN DELIVARY: Professor in Charge, NITKS Hostels reserves the right to allow or not to allow the purchaser to lift the materials with or without the Ground Rent after the expiry of stipulated delivery period and delayed charge will be 1% of the original total cost of the scrap only.
- 15. In event of the material not lifted by the purchaser in entirely the contract stands automatically cancelled thereby forfeiting the Security Deposit.
- 16. QUALITY & QUANTITY: The goods are offered purely on 'AS IS WHERE IS' basis. Pick and choose method of collection is strictly prohibited. The tenderer should thoroughly satisfy themselves about the nature, conditions and quality of material at the time of inspection.

- 17. LIFTING & COLLECTION: Lifting of all scrap from "as is where" basis will be the total and complete risk and responsibility of scrap purchaser only. The purchase should follow the procedure of NITK with regard to entry of vehicle, issue of material in force at the time of taking delivery. Cost of segregation / Cutting / bundling / loading / unloading / transportation etc. of scrap materials are to be borne by the purchaser (s).
- 18. All statutory requirement and labour enactments should be strictly followed in respect of persons employed by the Purchaser(s).
- 19. The purchaser's representatives, workers, lorry drivers and other will have to strictly observe the working hours and regulations regarding the discipline and security while they are inside the premises of NITKS Hostels. Any violation of the regulation regarding discipline and security will lead to forfeiture of Security Money and termination of the contract by the Professor in charge, NITKS Hostels at his discretion.
- 20. The highest bidder has to pay the quoted amount on or before 4.00 PM on 5 June, 2019 and lift the materials immediately (before 10<sup>th</sup> June, 2019) at his own cost and risk, failing which the Security Deposit will be forfeited and the firm will be black listed any other levies chargeable as per rules in force shall have to be borne by the bidder, and also GST @18% to be borne by the successful bidder as applicable.
