Chairman welcomed all the members to the 41st meeting of the Board of Governors.

Prof. Swapan Bhattacharya, Director, NITK pleased to inform the BOG that all the nine Under Graduate programmes of the Institute has been granted with accreditation status by the NBA for full five years and further informed that NITK is the only Institute in the country to get such accreditation for all the UG programmes at a time.

After a brief discussion, with the permission of the Chair, the Secretary, BOG began the deliberations on Agenda items.

Item No. 41.1: Confirmation of the Minutes of 40th meeting of the Board of Governors held on 15-11-2014.

The minutes of the 40th meeting of the Board of Governors held on November 15, 2014 were read and confirmed.

Item No. 41.2: To consider the report on the action taken on the minutes passed in the 40th meeting of the Board of Governors held on 15-11-2014.

The action taken on resolutions of the 40th meeting of the Board of Governors held on November 15, 2014 was noted and approved.

As regards to engagement of manpower through the contractor, the BOG suggested that the Institute shall ensure adherence of all labour laws and statutory payments to the workers by the contractor through regular checking.

Item No. 41.3: To consider the items placed before the 41st meeting of the Board of Governors held on 28-02-2015:

Item No. 41.3.1: To consider IPR Policy ["Intellectual Property Rights" policy].

After discussion on the matter, the Board resolved to approve the IPR policy in principle. The Board further suggested that the contents of the IPR policy may be compared with that of policies in IITs.

Item No. 41.3.2: To consider adoption of villages under Unnat Bharat Abhiyan Scheme.

The Board noted the proposal of adoption of five villages by the Institute under Unnat Bharat Abhiyan Scheme of the Government of India. The BOG suggested that priority for objective may be given for education and betterment of women.

Item No. 41.3.3: To consider Advisory committee at department level.

The Board noted the composition of advisory committee of different departments. The Board resolved to approve the constitution of the advisory committee with a suggestion that new names may be considered for the Department of IT for representing various technical aspects of the department.

The BOG suggested that clear TOR (Terms of Reference) and Term of the Committee may be (2 years) framed before the issue of orders on constitution of the advisory committee.

Item No. 41.3.4: To consider Recruitment of faculty members.

Advertisement for recruitment of faculty members in 4-tier flexible cadre system was made on 24-06-2014 for 148 vacancies in major national newspapers as well as it was put up in the Institute website for a total vacancy of 148 positions at various cadre.

A Total of 1,658 applications (including 222 from internal faulty members) have been received from which 873 had been short listed. All 6 Deans and 13 HODs (excluding one who is not eligible for not having Ph.D) were amongst these applicants. As resolved in the previous BOG, none of the faculty members (including Deans and HODs) were involved in the process of recruitment. Two Visitor's nominees for selection committee helped the screening process. Constitution of Selection Committee and criteria for selection of candidates has been made in accordance with the provisions of NIT Act / Statutes, Recruitment Rules and MHRD guidelines.
