Racks dimensions to fit installations and site visit is recommended for a thorough understanding.
3	Query 3: The Installation, testing and commissioning charge column is not available in price bid format.	Price should be quoted inclusive of all.
4	Query 4: Please confirm that Pre-Bid conference attendance is must to bid the Tender.	No.
5	Query 5: Some major items are missing in BOQ like UPS, Power cable and installation accessories.	UPS will be provided; all other items must be supplied as per specifications. A site visit is recommended for a thorough understanding before bid participation.
6	Page No. 10, Section 1B: Instruction to bidder (ITB) Query 6: SI. No. 22 Terms of payment, a) Payment within 30 days from the date of delivery, installation and acceptance certificate of concerned Department/ Section/Purchase section: In the BOQ 2 years CAMC is also there, but in payment terms mentioned "within 30 days from the date of delivery, installation, and acceptance certificate of the concerned" Does it means is NITKSH will made payment, including CAMC payment? Because there is no where mention CAMC payment separately, Please Confirm.	CAMC payment will be made yearly after the expiry of the warranty period.
