Provisional Result of Scrutiny of Applications for post of Assistant Registrar

With reference to the recruitment rules / criteria which is appended in this document, the provisional result of scrutiny of applications for the post of Assistant Registrar is published on the basis of the information submitted in the application and the supporting documentary evidence provided by the applicant. The listed candidates are required to enroll for Computer Based Test (CBT), which will be scheduled at **Bangalore** during the month of July 2025. This test is to facilitate shortlisting of applicants for the next stage of recruitment. You have to plan your travel to Bangalore to appear for the CBT and return to your place after participating in the CBT.

The list of application numbers of the candidates who are eligible to participate in the Computer Based Test (CBT) which will be held in the month of July 2025 is published herewith.

This provisional result of scrutiny of applications is subjected to the candidate fulfilling the following conditions:

- (1) The candidate has gone through the eligibility criteria published in the recruitment notification such as age, educational qualifications, experience, other requirements of statutory certificates and documents for the post applied by the candidate.
- (2) After ascertaining that the candidate is in possession of all original documents to which are required to establish meeting the eligibility criteria for the post applied by him /her, the candidate has submitted the application.
- (3) The candidate is aware that his/her participation in the recruitment process is subject to verification of all original documents by NITK authorities.
- (4) The candidate is aware that it is his/her responsibility to submit the required original documents to NITK authorities establishing his/her candidature meeting the eligibility criteria for the post.
- (5) The candidate is aware that, in the event of failure to establish his /her candidature meeting the eligibility criteria, his /her candidature will be cancelled by NITK authorities at any stage of recruitment process.
- (6) In such an event of cancellation of his/her candidature by NITK authorities for any reason, the candidate is aware that fees paid by the candidate will be forfeited and the candidate will not hold NITK liable from administrative, financial and legal matters in this regard.

After having ascertained that you fulfill all the above conditions, the candidate can proceed to enroll for Computer Based Test (CBT), by responding to email sent their email address.

[Note: The remaining applicants have not established their candidature because of non-satisfying one or more eligibility criteria such as age, educational qualifications, experience, other requirement of statutory certificates and hence are not eligible to participate in the recruitment process]

The CBT Test Structure and Syllabus has been notified on the Institute website. The CBT Enrolment Fee of Rs. 1,000/- has to be paid by candidates of all categories to enroll their participation in the CBT. Upon payment of CBT Enrolment fee, a unique CBT Enrolment Number is assigned to the candidate. Only such candidates who have enrolled for CBT by remitting the CBT Enrolment fee will be permitted to appear for CBT and the call letters to appear for CBT with due instructions and venue of CBT will be sent by email to them.

The CBT Enrolment fee after deducting bank charges **will be refunded to their bank account** for such **candidates who appear for the CBT**. If any candidate fails to appear for CBT, then CBT Enrolment Fee will be forfeited.

The results of the CBT will be announced on the Institute's website at a later date. The candidates are advised to visit the Institute Website regularly for necessary updates.

The Last date for payment of Computer Based Test Enrolment Fee is 20-06-2025.
No Extension of Time will be given for payment of CBT Enrollment Fee.
