<u>5. Instructions to the candidates:</u>

A. Physical reporting and admission

The date of physical reporting, document verification and admission for all the candidates who have been allotted a seat at NITK Surathkal through DASA 2025 is scheduled on 25st August 2025, Morning session: 9.00 am to 1.00 pm and Afternoon session: 2.00 pm to 5.00 pm.

Candidates are advised to fill their details through the NITK IRIS portal on clicking the MIS link mentioned below and pay the prescribed Institute's fee / Hostel's Fee before final physical reporting and admission. (If it is not possible to fill-in the details before reaching NITK, arrangements will be made to use the computer facilities at NITK).

The login credentials for NITK IRIS admission portal <u>https://iris.nitk.ac.in/admission/admissions/login</u> will be sent to candidates by email on or before <u>24th August 2025</u>.

Documents to be submitted by the selected candidates at the time of physical reporting:

- 10. Passport of Parent employed in Gulf Countries (for CIWG only)
- 11. Parent's valid VISA (for CIWG only)
- 12. Parent's work permit (for CIWG only)
- 13. Letter from company of parent working in Gulf Countries (for CIWG only)
- 14. Authenticated Citizenship card (for applicant who are nationals of Nepal without passport)
- 15. Medical fitness Certificate (Annexure attached)
- 16. Original Migration certificate of last institute/university attended.
- 17. Original Conduct / Character Certificate from head of the institution last attended
- 18. Original Transfer certificate from the head of the institution last attended

B) Hostel facilities

The hostel room allotments will be done at the time of physical reporting. The candidates may come prepared to stay in the hostel soon after the admission formalities. Mess facility will be available from the date of reporting to the Hostel.

Hostellers are required to pay the applicable mess fee at the time of admission to the Hostel. The mess fee is **Rs.35,310**/- for first semester.

D) Orientation program and Commencement of classes

The orientation /induction programme will be held during $26^{th} - 31^{st}$ August 2025. The classes for the first semester B.Tech students for the academic year 2025-26 would commence from September 1^{st} (Monday), 2025.

E) Refund of fees

Any student who withdraws admission before the closing date of admission is eligible for the refund of all the fees and deposits, after deduction of a processing fee of Rs.1000 /- (Rupees One Thousand Only) Candidates who withdraw the admission after the closing date of admission are eligible for refund of only the caution deposit paid to the Institute. They are not eligible for refund of any other fee. Candidates who are leaving the course after joining are not eligible for any refund.

F) Banking Facility

SBI and Canara Bank Branches with ATM facility are availableon Campus. All students must compulsorily open SB account in either of above two branches and inform the academic section of their SB account numbers.

G) Location and How to reach NITK

The National Institute of Technology Karnataka (NITK) is located in Mangalore City, Karnataka, India. It is situated along the Kanyakumari-Mumbai National Highway 66. Mangalore, also known as Mangaluru, is a coastal city in the southwestern part of Karnataka, and NITK is positioned in the outskirts of this city with a campus set amid 300 acres of lush green surroundings with the Western Ghat Mountains to the east and the Arabian Sea to the west. With a temperature range of 18 to 38 degrees Celsius, the location has a fairly moderate and pleasant climate throughout the year and the fact that the campus is situated on the seashore adds an extra element of appeal with a refreshing and healthy climate. This location provides not only a peaceful and conducive environment for academic activities but also convenient connectivity to major cities in India and international destinations via road, rail, and air. All Service/Express Buses starting from Mangalore Bus Stand and going towards Udupi, stop near NITK Main Gate. A number of Private Taxis also available at Mangalore.

Mangalore Railway Station, located about 20 km away from the campus, ensures convenient rail access. Additionally, the Surathkal Railway Station being approximately 3 km away further enhances the connectivity for the NITK community. The Mangalore (Bajpe) airport being in close proximity, about 20 km away, adds to the ease of transportation. This airport serves as a vital link for both domestic and international destinations, making it convenient for students, faculty, and visitors to travel.

H) Ragging
