# Scholarship to the BC/MBC/DNC students pursuing UG/PG Courses in the Institutions of Govt. of India (viz) IIT, IIM, IIIT, NIT and Central Universities.

The Govt. of Tamil Nadu have issued orders to grant Scholarship to the students belonging to BC/MBC/DNC Communities who are pursuing UG/PG Courses in the Institutions of Govt. of India like IIT, IIM, IIIT, NIT and Central Universities.

#### Conditions:

- 1. The student should belong to BC/MBC/DNC
- 2. The student should be a native of Tamil Nadu.
- 3. The student should pursue UG/PG Courses in IIT, IIM, IIIT, NIT and other Central Universities.
- 4. The family annual income should not exceed Rs.2.50 Lakh Per Annum
