General Terms and Conditions:

You are required to adhere to the below mentioned terms and conditions:

- 1. **Discount/ Special Offers:** All the books carry a flat discount (for both Indian and Foreign) as per the agreement
- 2. **Conversion Rates:** In case of BOOKS with price in foreign currency, 'STATE BANK OF INDIA' (SBI) conversion rates prevailing on the date of remittance to respective publishers.
- 3. **Order Acknowledge:** The order should be acknowledged within 7 days from the date of order.
- 4. **Editions of Books:** Only latest editions to be supplied. If available, always paperback/ Indian reprint editions will be supplied unless otherwise mentioned.
- 5. **Paperback/Hardback:** If paperback edition is not available, then consult library beforehand if you intend to supply hardback editions.
- 6. **Book Supply Time:** The maximum time limit for supplying Indian books is 30 days and foreign books is 60 days.
- 7. **Blacklisting Vendor:** In case of non-supply of books within the stipulated time for successively three times, the vendor will be removed from the empanelment and blacklisted for future supply, unless the vendor communicate the reason for the delay in supply with valid proof.
- 8. **Order Cancel:** This order would be treated as cancelled, if the books are not supplied or no report as to availability or otherwise is received within this period.
- 9. **Price Proof:** Enclose valid price proof certified by you along with the invoice

- 10. **Transportation Charges:** Books must be supplied to the Library with No Transportation charges and No other/extra charges are admissible.
- 11. **Payment:** The final payment shall be made in Indian Rupees within 45days from date of receipt of the invoice, by a crossed check/Demand Draft/NEFT/RTGS in favour of your agency as per your invoice/s. The Final Invoice/s in triplicate shall be submitted along with the Proof of Remittance/s, Publishers Price Proof, SBI proof of conversion rates as on the date of remittance/s, and a Photocopy of your agency's PAN card/GST details for the payment.
- 12. **Remittance Proofs:** Your final invoice for payment should be supported with the 'proof of remittance/s', made to the respective publishers in this regard in case of BOOKS with price in foreign currency.
- 13. **Replacement Copy:** In case of BOOKS, if any, received in mutilated/ torn condition shall be replaced with a fresh copy.
- 14. **Document Enclosures:** Last 3 years turnover statement and 3 Reference letters from Reputed CFTI institutes like IISc/IITs/NITs/IISERs/IIMs etc.
- 15. The court of Mangalore alone will have the jurisdiction to try any dispute between the bidders and the Institute arising out of this service. It is specifically agreed that no court outside and other than court in Mangalore shall have jurisdiction in the matter.
- 16. NITK, Surathkal reserves the right to modify/change/delete/add any further terms and conditions prior to issue of agreement.
- 17. Arbitration- All dispute and differences which may arise between the NITK, Surathkal and the Book Supply Agency shall be referred to Director, NITK, Surathkal whose decision shall be binding on all concerned.
