Terms and Conditions

1. The rates should preferably be quoted on a FOR destination basis for services to be rendered within India.
2. The bidder shall clearly indicate any applicable tax exemptions, including GST exemptions, if applicable to the services offered.
3. The rate quoted should be on a unit basis (where applicable). Taxes and other statutory charges should be quoted separately, considering exemptions if any. The rate should be quoted in INR only.
4. The rate quoted should be inclusive of all service-related components, including deployment, execution, testing (if applicable), commissioning (if applicable), implementation, documentation, and training, as required under the scope of work.
5. Payment: No advance payment will be made. Payment will be released only after satisfactory completion of the services in accordance with the contract terms and submission of the required performance security by the service provider.
6. The guarantee/warranty period (where applicable) for the services provided should be clearly specified. The complete period should be indicated in Section 3 of this tender document.
7. The required timeline for commencement and completion of services should be specified in Section 3 of this tender document.
8. In case of dispute, the matter will be subject to Mangalore Jurisdiction only.
9. **Delivery Period:** The Delivery Period/Time shall be deemed to be the essence of the Contract and delivery must be completed not later than such date(s). If the Supplier does not perform its obligations within the Delivery Period/Date mentioned in the Contract, the same would constitute the breach of the Contract and the Institute shall have the right to cancel or withdraw the Contract for the unsupplied portion after the expiry of the original or extended delivery date or period stipulated in the Contract. Such cancellation of the contract on account of non-performance by the Supplier would entitle the Buyer to forfeit the EMD/Performance Security besides other actions such as debarment from the Institute as per GFR 2017.
10. **Liquidated Damages:** Timely delivery is the essence of the contract and hence if the Supplier fails to deliver Goods within the original/extended delivery period(s) specified in the contract, the Institute will be entitled to deduct/recover the Liquidated Damages for the delay, unless covered under Force Majeure conditions aforesaid, **@ 1% per week or part of the week of the delayed period** as pre-estimated damages not exceeding 5% of the contract value without any controversy/dispute of any sort whatsoever.
11. The bidder needs to comply with restrictions under rule No 144 (xi) of GFR (General Financial Rules) 2017 and the clause pertaining to Public Procurement Division Order (Public Procurement no 1,2 & 3 vide ref. F.No.6/18/2019-

PPD dated 23.07.2020 and 24.07.2020 of Dept of Expenditure (DOE), Ministry of Finance). In this Connection Bidder has to submit Self Certification (as per Annexure A or B), depending on the status of the bidder.

12. The bidder needs to submit a Self-certification in line with Make in India, Public Procurement Order No. P-45021/2/2017-BE-II dt. 15.06.2017, P 45021/2/2017-PP (BE-II) dated 28.05.2018, P-45021/2/2017-PP (BE-II) dated 29.05.2019 and P45021/2/2017- PP (BE – II) dated 16.09.2020 of DPIIT, Ministry of Commerce & Industry. The Bidder who will not meet this criterion will be rejected in the technical bid. The Self-certification should be provided as per Annexure C.

13. EMD must be in the form of Bank Guarantee **Annexure-D** (DD/e-Payment mode through Net Banking). It will be valid for 180 days from the date of opening of the tender. In case of EMD payment made through E-Payment, UTR Number with details should be uploaded. The firm registered with MSME/NSIC as per MSME procurement policy order 2012 will be exempted from submission of EMD. Intended parties will have to give proof of registration along with their tender. EMD of the unsuccessful bidders shall be refunded without any interest at the earliest after finalization of the purchase of the concerned item.

a. The EMD will be returned to the BIDDERS(s) whose offer is not accepted by NITK within one month from the date of the placing of the purchase order(s) on the selected BIDDER(s). In the case of the BIDDER(s) whose offer is accepted the EMD will be returned on submission of Performance Security in the form of Bank Guarantee (BG). However, if the return of EMD is delayed for any reason, no interest/penalty shall be payable to the Bidders.

b. The successful BIDDER, on the award of contract/order, must send the contract/order acceptance in writing, within 15 days of award of contract/order failing which the EMD will be forfeited.

Detailed Specifications

Specifications:

The Ministry of Ports Shipping and Waterways (MoPSW) is developing a roadmap for ease of doing business and re-engineering business processes leveraging automation and technology at the affiliated MoPSW organisations. The project has NITK as technological partners responsible for researching and developing the technology required and helping implement it at these organisations. As part of the same, initial studies had to be carried out to understand port processes, benchmark the processes and identify areas requiring re-engineering. In addition to the same, a new set of data needs to be collected and the existing data needs to be validated to help identify state of the art technologies that can be directly implemented or needs to be further developed to improve port processes.

Minimum Eligibility Criteria

1. More than three years of experience in aiding R&D setups with data collection and validation.
2. The agency should have a full-fledged physical office and should be able to provide a full-time staff during the data collection process on campus for real-time data collation and coordination.
3. The agency should have prior experience working with companies/individual members who are part of the port ecosystem. Provide documentary evidence for both.
4. Agencies who have previously worked on engineering tech projects are preferred.
5. The team working on this project should include at least one engineering professional who graduated from any of the top of engineering colleges (preferably NITs/IITs) as per NIRF Ranking – and has international work experience in the Engineering field.
6. The agency should not be blacklisted by any Central/State Government/Public Sector Undertaking in India.
7. Registration: The bidder should be an income tax payer and should be registered with the GST Department.
8. The agency should have PAN India presence or should be able to allocate one person per port to the 12 ports that will be part of the R&D project.

Scope of Work

1. Collect additional data from major Indian ports, IWAI, CSL, SCI, IMU, DGS and DCI as directed by NITK.
2. Analyse as-is status and future plans underlined by the ports.
3. Review international port processes and identify gaps with MoPSW organisations.
4. Allocate individuals at request to study live processes at MoPSW organisations if required.
5. Collaborate with the tech team in identifying the right re-engineering process to help develop/implement state-of-the-art engineering processes.

Other Important Conditions

The agency should be willing to collaborate with NITK continuously until the report is submitted satisfactorily to the Port.

The agency will have to work with NITK for a period of ONE year (post completion of this particular requirement) to quality-check the output delivered and until the final guideline is implemented and regularised in the Port whichever is later.
