Annexure -I

<u>The revised guidelines for continuation of GATE scholarship for M.Tech and</u> <u>M.Tech (Research) students.</u>

- i. Student should have registered and passed in all courses listed in the suggested plan for study for I Semester and secured a SGPA not less than 6.0 at the end of I semester in order to be eligible for the continuation of full GATE stipend. However, students who have passed in all courses with SGPA less than 6.0 at the end of I semester will be awarded 50% of the entitled stipend for II semester and the full GATE stipend will be restored if the candidate secures a CGPA of 6.0 at the end of II semester.
- ii. Student should have registered and passed in all courses listed in the suggested plan for study for I & II Semesters and secured a CGPA not less than 6.0 at the end of II semester in order to be eligible for the continuation of full GATE stipend. However, students who have passed in all courses with CGPA less than 6.0 at the end of II semester will be awarded 50% of the entitled stipend for the remaining duration of study.
- iii. In case of M. Tech (Research), a student at any stage should have passed in all the registered courses with a SGPA/CGPA not less than 6.0 in order to be eligible for the continuation of GATE stipend.
