The Pre-Bid Meeting for the Tender Notification No. **NITK/AC-1/FC-01/26-27/DOC04** dated **08.06.2026**, **Food Court – Restaurant Services at NITK Surathkhal** was held on 18.06.2026 at 4:30 PM in the CCMT Hall, Main Building, NITK Surathkal. Queries received from prospective bidders through e-mail and those raised during the meeting were duly examined.

The Institute's clarifications/responses and the consequent corrigenda, wherever applicable, are furnished below. These shall be read in conjunction with the tender document and shall form an integral part thereof.

<b>Query of Bidder</b>	<b>Clarification</b>
<p>With reference to Tender Notification No. <b>NITK/AC-1/FC-01/26-27/DOC04</b> dated <b>08.06.2026</b>, we seek clarification on the following points:</p> <ol style="list-style-type: none"><li>1. On <b>Page No. 30</b>, it is mentioned that the sale of <b>ice cream, juice, and chat items is not allowed</b>.</li><li>2. However, on <b>Page No. 35</b>, rates for such items appear to be specified.</li></ol> <p>Kindly clarify whether these items are permitted</p> <p>Further, if the sale (Ice cream, Juice, chat) of items is allowed to <b>outsiders</b> please clarify:</p> <ul style="list-style-type: none"><li>• Who will be cleaning and maintaining the dining area?</li></ul> <p>We request your clarification on the above points to enable proper submission of our bid.</p>	<p>Refer to Annexure I</p>

The **Category B. Cold Beverages of Table 2 (Fixed Price list of items), Page No. 35 of Tender Document** is amended as:

The items **Lassi (Sweet), Lassi (Salty), Fresh Fruit Juice, Assorted Cold Drinks, Ice Cream, and Frooti** are hereby withdrawn from Category B of Table 2.

Only **Mineral Water** shall be permitted for sale at **MRP**, and the bottle capacity shall be restricted upto **2 litres only**.

"The bidder who offers the highest License Fee [*over and above the minimum License Fee*] will be the successful bidder. If the rates of two/three bidders are found equal/same, then the shop/establishment would be allotted at the discretion of NITK."

**Shall be read as:**

**Section 2 - Terms and Conditions**, Clause (v) shall stand amended and shall be read as follows:

"The bidder quoting the **Highest Rent/Month in Rs. (Excl. GST)** shall be declared the successful bidder. In the event of a tie between two or more bidders quoting the same Highest **Rent/Month in Rs. (Excl. GST)**, the following tie-breaking criteria shall be applied in the order indicated below:

- i. Higher average Annual Turnover during the last three financial years;
- ii. Higher experience in providing Restaurant/Catering/Food Court services; and

**\*\*All other terms and conditions of the Tender Document shall remain unchanged and shall continue to be applicable. \*\***
